Dear Ms. McNeal:

By its July 30, 2018 application in Case No. 18-1208-ST-ATA, Ohio Wastewater Systems, Inc. ("OWSI") requested approval of a change to its current bill format set forth in Appendix B to its tariff, P.U.C.O. No. 1. The Commission staff ("Staff") subsequently requested that the proposed bill format be revised to incorporate certain additional information. Accordingly, on August 16, 2018, OWSI filed an amended version of the proposed bill format that was consistent with the Staff recommendation.

Although Staff, by its report dated August 30, 2018, recommended approval of the application, the Commission did not act on the application within 45 days. This meant that, pursuant to Rule 4901:1-15-23(B), Ohio Administrative Code, the revised bill format was automatically approved effective the 46th day from the date of filing, or September 14, 2018. OWSI filed the new Appendix B bill format for inclusion in its TRF docket on September 17, 2018. However, Staff recently brought it to my attention that the version of Appendix B filed on that date was the version filed with the application and not the amended version that had been submitted on August 16, 2018. Thus, a copy of the correct, approved version of the bill format is attached, which is to be filed in OWSI's TRF docket, Case No. 89-7054-ST-TRF, and substituted for the version of Appendix B that was inadvertently included in the September 17, 2018 filing. I apologize for this error and any confusion it has caused.

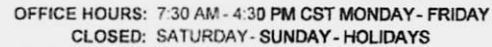
