Re: PUCO Case No. 18-55-RR-FED- In the Matter of a Request for Upgrades to the Active Warning Devices at CSX Transportation Inc. Grade Crossing, DOT# 503-591W, on Waterloo Road in Summit County, Ohio.

On November 27, 2017, the Ohio Rail Development Commission (ORDC) authorized funding for CSX Transportation, Inc. (CSX) to upgrade the active warning devices to LED lights at the Waterloo Road, DOT#503-591W, grade crossing in Summit County, Ohio. The crossing was surveyed, on March 28, 2017, and was found to warrant the upgrades.

On January 31, 2018, the Commission approved the project and ordered completion by October 31, 2018.

On October 31, 2018, CSX filed for a 60 day extension. In the request, CSX states that due to an error in their material ordering system, the material for this project has been delayed. They expect to receive this material within 30 days and the field crews are ready to install and complete the work within a week of the material being delivered.

ORDC has indicated to Staff that they not opposed to the extension request. Staff recommends that the Commission grant the 60 day extension request.
