Do you have before you a copy

11 of your prefiled testimony that has been marked as 1 2 Staff Exhibit 2? 3 Α. I do. Ο. Thank you. And was this testimony 4 5 prepared by you or at your direction? 6 Α. It was. 7 Q. Thank you. Do you have any changes or corrections to this testimony? 8 9 Α. I do have one change. 10 Ο. And what is that, sir? 11 On page 2 of my testimony, line 15, under Α. 12 Question 5, the response, the date listed on that is 13 October 16, 2018, as to the document that I was 14 supporting. That was the Joint Stipulation. It was 15 actually filed on October 15, 2018. October 16 was 16 the due date, I believe, that the Administrative Law 17 Judge had set, but it was filed a day early. 18 Ο. Thank you. Did you have any other 19 changes? 20 Α. No, sir. 21 Ο. Thank you. So if I were to ask you all 22 the questions contained in this exhibit, would your 23 answers be the same? 24 Α. Yes. 25 Q. Thank you. And do you also have before

12 you a copy of the Staff Report of Investigation that 1 2 has been marked as Staff Exhibit 1? 3 Α. I do. Thank you. Were you the person in charge 4 Ο. 5 of preparing this report? 6 Α. Yes, sir. 7 Thank you. And does it accurately Q. reflect the results of Staff's investigation? 8 9 Α. Yes. 10 MR. LINDGREN: Thank you. 11 I have no further questions. The witness 12 is available for cross-examination. 13 THE ADMINISTRATIVE LAW JUDGE: The Bench 14 has no questions. 15 Insofar as support of the Stipulation, is 16 that contained within the testimony? 17 MS. BLEND: Thank you, your Honor. 18 Ms. Cross was the witness for the Company supporting 19 the stipulation. 20 THE ADMINISTRATIVE LAW JUDGE: Okay. 21 MS. BLEND: Her testimony addresses the 22 three-prong test the Board requires in the 23 Stipulation. A copy of the Stipulation is attached 24 to her testimony as Exhibit AMC-1. 25 THE ADMINISTRATIVE LAW JUDGE: Thank you.

13 1 MR. LINDGREN: Your Honor, Mr. Pawley's 2 prefiled testimony also notes that Staff supports the Stipulation. 3 4 THE ADMINISTRATIVE LAW JUDGE: Thank you. 5 Mr. Pawley, you are excused. 6 Any other matters to come before the 7 Bench? 8 MR. LINDGREN: Your Honor, I would move 9 the admission of the Staff Report of Investigation 10 filed in the docket on September 25, 2018, and I have 11 marked that as Staff Exhibit 1. I also move for the 12 admission of Staff Exhibit 2, which is the prefiled 13 testimony of Jon C. Pawley. 14 THE ADMINISTRATIVE LAW JUDGE: The 15 documents will be marked as indicated and admitted 16 into the record if there is no objection. 17 MS.
