Generation Pipeline LLC (Generation) is proposing to construct a steel natural gas pipeline (Project). The Project will be 16” in diameter and approximately 1.54 miles in length. The Project will begin at an existing 24” transmission pipeline west of North Lallendorf Road and north of Seaman Road in Oregon Township, Lucas County, Ohio. The Project will extend northwest paralleling CSX railroad tracks across Corduroy Road, Otter Creek Road and York Street before turning north across the railroad tracks across BOC America Gas property and then northwest to an end user facility. The end user facility is the new IronUnits LLC iron briquette processing plant.

In accordance with Ohio Revised Code Section 4906.03(F)(3), this project falls within the requirements for an accelerated review by the Ohio Power Siting Board (“OPSB”). Per the requirements of Ohio Administrative Code Rule 4906-6-07(A)(1), I am submitting the following on behalf of Generation:

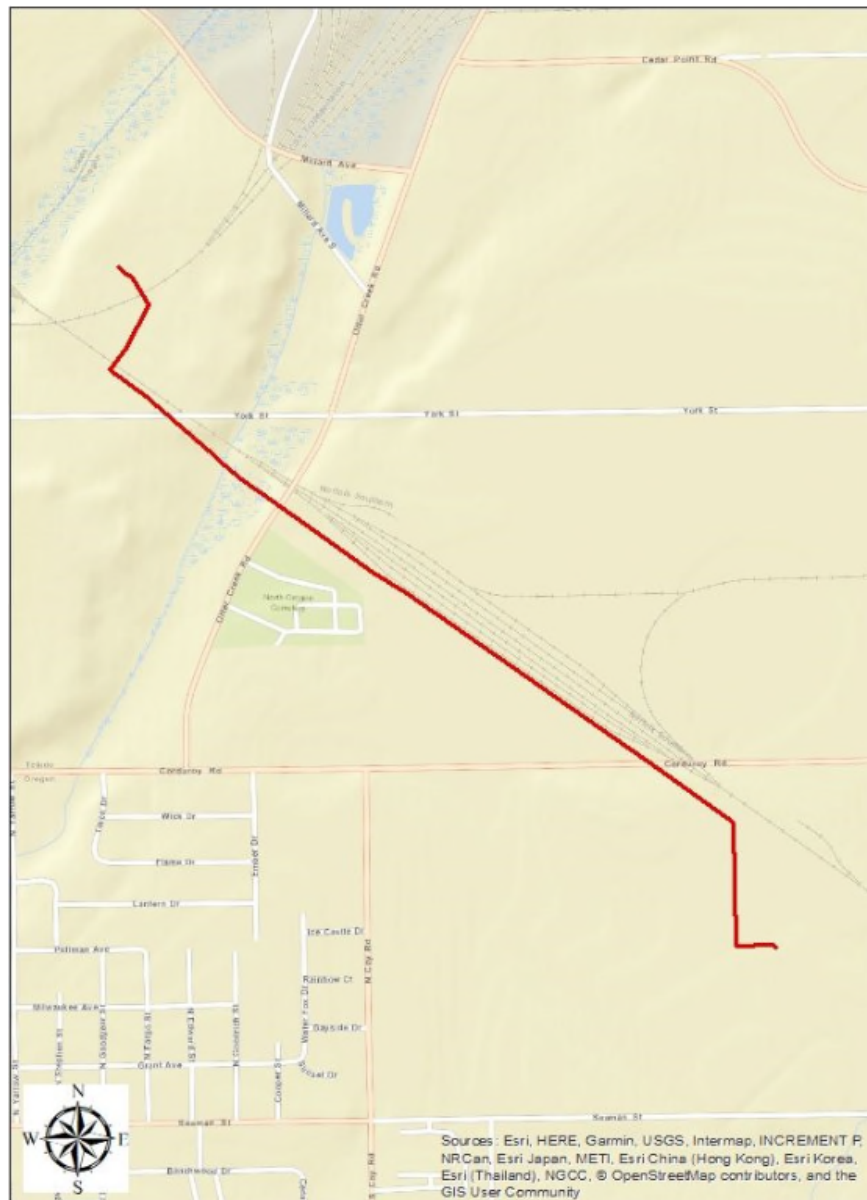

Notice of Proposed Major Utility Facility

Generation Pipeline LLC (Generation) is proposing to construct a steel natural gas pipeline (Project). The Project will be 16" in diameter and approximately 1.54 miles in length. The Project will begin at an existing 24" transmission pipeline west of North Lallendorf Road and north of Seaman Road in Oregon Township, Lucas County, Ohio.
