FIRST: On August 27, 2018 Applicant filed an Application and Statement in this Case No. 18-1339-EL-AIS with this Commission requesting that the Commission issue an Order authorizing Applicant to participate in the AEP System Utility Money Pool, and to make short-term borrowings from the Money Pool or to make short-term borrowings from American Electric Power Company, Inc., AEP Transmission Holding Company, LLC or AEP Transmission Company, LLC of up to \$250,000,000 from time to time, through December 31, 2019. of Oklahoma, Southwestern Electric Power Company, Wheeling Power Company, Blackhawk Coal Company, Cedar Coal Company, Central Appalachian Coal Company, Dolet Hills Lignite Company LLC and Southern Appalachian Coal Company (the "Participants"), American Electric Power Company, Inc. ("AEP") and AEP Utility Funding, LLC ("Utility Funding").


