{¶ 1} Pursuant to Ohio Adm.Code 4901:2-7-12, Staff served a notice of preliminary determination (NPD) upon Steven J. Dodson (Respondent) alleging violations of the Commission's transportation regulations.

{¶ 2} On August 29, 2018, counsel for Respondent filed a request for an administrative hearing regarding the NPD as contemplated by Ohio Adm.Code 4901:2-7-13.

{¶ 3} By Entry dated October 29, 2018, the attorney examiner directed the parties to participate in a prehearing conference on December 18, 2018. Due to a scheduling conflict, and having communicated with Respondent's counsel, the attorney examiner continues the prehearing conference to Thursday, January 31, 2019, at 11:00 a.m.<sup>1</sup> At that time, the attorney examiner will attempt to contact Respondent's counsel, Mr. Michael J.
