- {¶ 1} R.C. 4905.04 provides that the Commission has statutory authority to regulate and promote the welfare and safety of railroad employees and the traveling public.
- {¶ 2} R.C. 4901.52 provides that when a railroad and street or highway cross at grade, if, in the opinion of the Commission, public safety requires protection, the Commission may make an order requiring the railroad to install such devices as, in the opinion of the Commission, will properly protect such crossing.
- {¶ 3} Cleveland Commercial Railroad (CCR) is a railroad as defined in R.C. 4907.02 and subject to the jurisdiction of the Commission under R.C. 4905.04.
- {¶ 4} On July 12, 2018, CCR filed a letter concerning grade crossings at E. 93rd Street (DOT#262418B) and E. 65th Street (DOT#262413S). Regarding the E. 93rd Street grade crossing (DOT#262418B), CCR explains that pedestrian gates were damaged from an automobile accident and were stolen. CCR requests that the Commission downgrade the crossing for removal of the pedestrian gates. CCR also requests a downgrade of the E. 65th Street grade crossing (DOT#262413S) for removal of the pedestrian gates. CCR notes that one of the two tracks at each crossing has been removed, and the track speed has been reduced from 50 miles per hour to 10 miles per hour, with an average of only three to four round trip trains using each crossing per week.
- {¶ 5} The attorney examiner finds that Staff should file a report of investigation regarding CCR's request by January 25, 2019.
