**RIDER USR**

**UNIVERSAL SERVICE FUND RIDER**

**APPLICABILITY**

Ohio Amended Substitute Senate Bill No. 3 established a Universal Service Fund in the State of Ohio. This Rider is applicable to all jurisdictional retail customers, including interdepartmental sales, in the Company's electric service area.

**CHARGE**

All kWh are subject to the Universal Service Fund Rider. The amount to be charged monthly beginning January 2, 2019 shall be as follows:

First 833,000 kilowatt-hours	\$0.0006774 per kWh
All Additional kilowatt-hours	\$0.0004690 per kWh
