SUBJECT: Suburban Natural Gas Company - Protest Rate Case

Suburban Natural Gas is proposing a price increase of the monthly service charge from \$29.42 to ~\$42. This does not include monthly usage and is charged regardless of use. Consumers serviced by Suburban Natural Gas do not have a choice in their provider. This is a monopoly. Columbia Gas charges a \$27 service charge. That's ~\$500 more year that we would be forced to pay because we don't have choice.
