of 2018 when I attempted to apply
for pipp with them, in order to manage
the fraudulent and improper and unfair
Bill I was unfairly denied pipp
By the C.A.A. Because the said that
I owed hundreds of dollars arrearages
to duke as part of my last pipp
payment installment agreement plan
which is not true because I
opted out of the program by rule
which exonerated of any arrearages owed
to duke no more than the total amount
I was behind in pipp payments
which was 162.00 total at the
address of 109 Glenridge place Apt. 1
Cincinnati, Ohio 45219. So I didn't violate
the pipp agreement plan. So once I
payed the 175.00 under the winter rule
in January 2018 once I did apply for
pipp I should have been granted
opportunity to do so. And because I was
denied pipp I was unable to manage the
Bill that was mines which in turn
would have left my utilities

Disconnected.

Thus for Sir At this time I would kindly appreciate it if this matter can be continued until after Jan 23, 2019 here immediately thereafter without dismissal of my complaint for failing to prosecute. Also I did prior to my brief incarceration consult with Ms Watts Duke Reps and we did discuss the matter fully and could not reach an agreement based on her evidence and my evidence and facts, coming to the conclusion that Duke would not lower or correct the Bill including other important factors that this commission is unaware of and must proceed before a hearing in order to rectify the matter and come to a fair resolution.

Further I request that the matter proceed to A hearing without having a hearing conference promptly because No Settlements seems imminent at this time with A full hearing. P
