- {¶ 2} On June 13, 2018, Mr. Michael Yemc, counsel for Mr. Bone, filed a request for an administrative hearing in accordance with Ohio Adm.Code 4901:2-7-13.
- $\{\P\ 3\}$ A prehearing settlement conference was held on August 8, 2018; however, the parties were unable to settle this matter.
- {¶ 4} On August 20, 2018, the attorney examiner scheduled the matter for hearing on November 8, 2018.
- {¶ 5} On September 27, 2018, the attorney examiner granted Mr. Yemc's motion to continue the hearing and scheduled the hearing to begin on November 15, 2018.
- {¶ 6} At the hearing on November 15, 2018, the attorney examiner granted the joint motion to continue the hearing until January 2019.
- {¶ 7} On January 14, 2019, the parties filed a joint motion to continue the hearing. The parties state that settlement discussions are still ongoing and request that a joint status report be filed in the docket by March 28, 2019.

If a resolution has not been reached by March 28, 2019, the parties are directed to file a status update informing the Commission on the progress of settlement discussions.
