Dear Ms. Turkenton and Ms. McNeal:

This letter serves as The East Ohio Gas Company d/b/a Dominion Energy Ohio's ("Applicant" or "DEO") pre-application notification letter in order for the Ohio Power Siting Board ("Board") to open a case for the proposed PIR 567 Front Street Pipeline Replacement Project, Cities of Akron and Cuyahoga Falls, Summit County, Ohio. This letter is given at least five (5) days prior to DEO's filing of a Construction Notice.

In accordance with Ohio Administrative Code ("OAC") Rule 4906-6-03(A), DEO provides the following information:

DEO is planning to replace approximately 625 feet of existing eight (8)-inch pipeline with 2,330 feet of twelve (12)-inch pipeline located in DEO easements. The new pipeline will be installed within the existing right-of-way and new DEO easement, and originates at the intersection of Howe Road and Front Street. The project area extends northeast along Front Street and terminates at the intersection of Front Street and Hillcrest Drive. The new pipeline crosses the Cuyahoga River along Front Street and will be crossed utilizing horizontal directional drill technology

**Anticipated Project Schedule:** The construction of the pipeline is anticipated to begin in April 2019. DEO plans to place the line in-service by June 2019.

**Expedited Treatment:** DEO requests expedited treatment for this application, and will submit payment of \$2,000.00 in accordance with OAC Rule 4906-6-04(A)(2).
