SENECA WIND, LLC'S SUPPLEMENT TO LETTER OF NOTIFICATION

On January 17, 2019, the Ohio Power Siting Board Staff issued its Staff Report, which contains the seven conditions listed below:

- 1) With the exception of tree clearing activities, construction of the facility may not commence until the Applicant has obtained a Certificate of Environmental Compatibility and Public Need for the Seneca Wind Project (ref: Case No. 18-0488-EL-BGN).
- 2) Prior to the commencement of construction, the Applicant shall finalize coordination of the assessment of potential effects of the proposed facility on cultural resources, if any, with Staff and the Ohio Historic Preservation Office (OHPO). If the resulting coordination discloses a find of cultural or archaeological significance, or a site that could be eligible for inclusion in the National Register of Historic Places, then the Applicant shall submit a modification or mitigation plan to Staff. Any such mitigation effort, if needed, shall be developed in coordination with the OHPO and submitted to Staff for review that it complies with this condition. If mitigation is not feasible, the Applicant shall submit a revised filing to the Board.
- 3) Prior to the commencement of construction activities in areas that require permits or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant.
- 4) The Applicant shall adhere to seasonal cutting dates of October 1 through March 31 for removal of any trees greater than three inches in diameter, unless coordination with the Ohio Department of Natural Resources (ODNR) and U.S. Fish and Wildlife Service allows a different course of action.
- 5) Construction in upland sandpiper preferred nesting habitat types shall be avoided during the species' nesting period of April 15 through July 31, unless coordination with the ODNR allows a different course of action.

- 6) Construction in northern harrier preferred nesting habitat types shall be avoided during the species' nesting period of May 15 through August 1, unless coordination with the ODNR allows a different course of action.
- 7) Construction in loggerhead shrike preferred nesting habitat types shall be avoided during the species' nesting period of April 1 through August 1, unless coordination with the ODNR allows a different course of action.

By this submission, Seneca Wind, LLC ("Seneca") incorporates the above conditions as a supplement to its Letter of Notification filed December 13, 2018, and requests that this supplement be considered part of Seneca's application.
