

Dear «ADDRESSEE»:

AEP Ohio Transmission Co., Inc. (AEP Ohio Transco), an affiliate of AEP Ohio, proposes to upgrade an electric transmission line in Tuscarawas County. This project involves rebuilding approximately 7 miles of transmission line to connect the new Yager Substation to the Desert Road Substation. The purpose is to ensure electric reliability and support economic growth.

AEP Ohio Transco submitted a siting application to the OPSB for this project on Sept. 22, 2016. The OPSB certified this application as complete on Sept. 20, 2016, based on requirements outlined in the Ohio Administrative Code (OAC) 4906-3-06 (A)(1). The OPSB approved this application and issued the certificate for the construction, operation and maintenance of the transmission facilities along the preferred route.

The enclosed amendment was filed with the OPSB on January 18, 2019. Copies have also been distributed to local government officials, the local public library and property owners in the project area.






