## ENTRY

Entered in the Journal on February 19, 2019

{¶ 1} On December 20, 2018, Drake, Andrew Residence – A Drake (Drake) filed an application in accordance with Ohio Adm.Code 4901:1-40-04(F) for certification as an Ohio renewable energy resource generating facility, as defined in R.C. 4928.01.

{¶ 2} Pursuant to Ohio Adm.Code 4901:1-40-04(F), Drake’s application is subject to a 60-day automatic approval process. Ohio Adm.Code 4901:1-40-04(F) further provides that, upon good cause shown, the Commission may suspend the certification of an application within the 60-day period of time. If an application for certification is suspended, the Commission may act to approve or deny the application within 90 days of the suspension.

{¶ 3} In addition, pursuant to Ohio Adm.Code 4901-1-07, if the last day of a period of time falls on a legal holiday, the period of time extends until the end of the next day that is not a legal holiday. Given that Drake’s application was filed on December 20, 2018, the 60th day of the time period was February 18, 2019; however, because February 18, 2019, was President’s Day, the 60th day extends until the end of February 19, 2019. Therefore, automatic approval of the application may be suspended on February 19, 2019.

{¶ 4} The attorney examiner finds that good cause exists to suspend the 60-day automatic approval process with respect to Drake’s application for certification, in order that the Commission and Staff may review this matter further.

{¶ 5} It is, therefore,

{¶ 6} ORDERED, That the automatic approval process for Drake's application be suspended. It is, further,

{¶ 7} ORDERED, That a copy of this Entry be served upon Drake and any other parties of record in this case.
