

Notice of Cancellation of Public Hearing

Seneca Wind, LLC (Seneca Wind) filed an application with the Ohio Power Siting Board in Case No. 18-488-EL-BGN for authority to construct, own, and operate a 212 megawatt (MW) wind-powered electric generation facility, Seneca Wind, on approximately 55,000 acres of leased private land in Scipio, Reed, Venice, Eden, and Bloom Townships, Seneca County.

Notice of public hearings was published on December 16, 2018. The local public hearing was scheduled for Tuesday, February 19, 2019 commencing at 3:00 p.m., and continuing until 9:00 p.m., at the Tiffin University, Marion Center, 235 Miami Street, Tiffin, Ohio 44883; and an adjudicatory hearing for Wednesday, March 6, 2019, at 10:00 a.m., 11th Floor, Hearing Room 11-A, at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215-3793.

Pursuant to a February 1, 2019 entry of the Ohio Power Siting Board, the local public hearing and the adjudicatory hearing have been cancelled due to a suspension of the procedural schedule. The two public hearings have been rescheduled to:

- (1) The local public hearing where the Board shall accept written or oral testimony from any interested persons, on **Tuesday, April 23, 2019** commencing at 3:00 p.m., and continuing until 9:00 p.m., at the Tiffin University, Marion Center, 235 Miami Street, Tiffin, Ohio 44883; and
- (2) The adjudicatory hearing to commence on **Thursday, May 16, 2019**, at 10:00 a.m., 11th Floor, Hearing Room 11-A, at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215-3793.
