SUPPLEMENT TO CONSTRUCTION NOTICE**

On February 22, 2019, the Ohio Power Siting Board Staff issued its Staff Report, which contains the six conditions listed below:

- 1) Prior to the commencement of construction activities in areas that require permits or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant.
- 2) The Applicant shall adhere to seasonal cutting dates of October 1 through March 31 for removal of any trees greater than or equal to three inches in diameter, unless coordination efforts with the Ohio Department of Natural Resources (ODNR) and the U.S. Fish and Wildlife Service (USFWS) allow a different course of action.
- 3) Prior to construction, the Applicant shall submit to Staff, for review and confirmation that it complies with this condition, a project construction plan which includes the specific locations of its laydown areas. If the specific locations chosen appear to have additional adverse impacts, the Applicant shall either propose different specific locations without such impacts, or refile its application.
- 4) The Applicant shall conduct no in-water work in perennial streams from April 15 to June 30 to reduce impacts to aquatic species and their habitat, unless coordination efforts with the ODNR reflect a different course of action.
- 5) The Applicant shall contact Staff, the ODNR, and the USFWS within 24 hours if state or federal listed species are encountered during construction activities. Construction activities that could adversely impact the identified plants or animals shall be immediately halted until an appropriate course of action has been agreed upon by the Applicant, Staff and the appropriate agencies.

- 6) The Applicant shall avoid construction in suitable nesting habitat for the American bittern between May 1 and July 31, unless coordination efforts with the ODNR reflect a different course of action.

By this submission, The East Ohio Gas Company d/b/a Dominion Energy Ohio (“DEO”) incorporates the above conditions as a supplement to its Construction Notice filed February 7, 2019, and requests that this supplement be considered part of DEO’s application.
