## THE PUBLIC UTILITIES COMMISSION OF OHIO

IN THE MATTER OF THE AUTHORIZATION OF CSX TRANSPORTATION TO UPGRADE ACTIVE WARNING DEVICES ON U.S. ROUTE 6 IN WOOD COUNTY.

## **ENTRY**

## Entered in the Journal on February 28, 2019

- {¶ 1} On January 3, 2018, the Commission issued a Finding and Order approving CSX Transportation's (CSX) upgrade of active warning devices to cantilevers and LED flashing lights at the U.S. Route 6 (DOT#228816S) grade crossing in Wood County. The Commission ordered completion of the project by October 3, 2018.
- {¶ 2} On September 4, 2018, CSX filed a request for an additional 90 days to complete the project. CSX explained that its work crew availability is limited while it completes positive train control (PTC) projects.
- {¶ 3} On September 25, 2018, Staff filed a memorandum responding to CSX's September 4, 2018 request. Staff stated that, while the Ohio Rail Development Commission (ORDC) did not oppose the extension request, ORDC noted that this is a safety project. Staff recommended that the Commission grant CSX's request to extend the completion date for 90 days, to January 3, 2019.
- {¶ 4} On November 12, 2018, CSX filed a second request for additional time. CSX reiterated the matter of limited crew availability because of PTC and asked that the project deadline be extended to April 3, 2019.
- {¶ 5} In a November 28, 2018 Entry, the Commission approved extending the project deadline to January 3, 2019, and emphasized that CSX should expedite work on the project.

{¶ 6} On December 1, 2018, Staff filed a memorandum in response to CSX's November 12, 2018 request to extend the project completion date to April 3, 2019. Staff stated that ORDC did not oppose extending the project deadline. However, Staff asserted, the project already had one 90-day extension. Staff recommended that the Commission grant only a 45-day time extension.

- {¶ 7} In a January 3, 2019, Entry, the Commission granted additional time, until February 18, 2019, for CSX to finish the project.
- {¶8} On January 18, 2019, CSX filed a request for 30 more days to complete the project. CSX explains that the project was scheduled to start on January 14, 2019, but was placed on hold awaiting project redesign. CSX adds that the redesign is expected to take approximately two weeks, after which the project will be placed back on the construction schedule.
- {¶ 9} Staff filed a memorandum on February 20, 2019, stating that CSX has provided a comprehensive construction schedule. Staff adds that on February 8, 2019, CSX indicated that construction would begin on February 19, 2019. Staff noted that ORDC does not oppose CSX's request. Staff recommends approval of an additional 30 days.
- {¶ 10} Pursuant to the Commission's September 19, 1996 Entry in *In re* 1996 Federal Crossing Protection Program, Case No. 96-676-RR-FED, the Commission authorized the attorney examiner assigned to the case to grant extensions for up to 30 days.
- {¶ 11} Upon review of CSX's request and Staff's recommendation, the attorney examiner finds that a 30-day extension of time should be granted. Unless otherwise authorized, CSX should complete the project as soon as possible, but no later than March 20, 2019.
- $\P$  12} CSX should notify Staff, ORDC, Ohio Department of Transportation District 2 (ODOT District 2), and Hancock Wood Electric Cooperative (HWEC) upon completion of

the project. At the time Staff or ORDC makes its final inspection and finds that the

installations are completed, Staff should file a memorandum in this docket indicating that

the project is completed.

 $\{\P 13\}$  It is, therefore,

{¶ 14} ORDERED, That CSX be granted a 30-day extension of time to finish the

project. It is, further,

{¶ 15} ORDERED, That unless otherwise authorized, CSX complete the project as

soon as possible, but no later than March 20, 2019. It is, further,

**[¶ 16]** ORDERED, That Staff and CSX comply with the provisions of Paragraph 12.

It is, further,

{¶ 17} ORDERED, That CSX follow all standard railroad crossing safety protocol to

ensure the protection of the traveling public at the crossing. It is, further,

**{¶ 18}** ORDERED, That a copy of this Entry be served upon ORDC, ODOT District 2,

HWEC, and any other interested person of record.
