On February 14, 2019, Hardin Wind Energy LLC ("Hardin Wind Energy") filed a notice regarding its General Electric ("GE") 2.8-127 turbine model. Attachment 2 to the notice, as clarified on February 21, 2019, reflects the turbine numbers for which Hardin Wind Energy is considering installing the GE 2.8-127 turbine model.

At this time, Hardin Wind Energy is filing this correspondence to note that Turbine 94 was inadvertently left off of the list of turbines being considered for the installation of the GE 2.8-127 turbine model. Please note that notice was provided to the landowner and adjacent landowners to Turbine 94 in accordance with O.A.C. Rule 4906-4-08(A)(5)(c). Further, to the extent a concern is raised by a landowner regarding the installation of such turbine model immediately adjacent to his/her property, this specific turbine will not be placed at that location.
