**NOTICE OF INTERVENTION AS A PARTY OF
THE PREBLE COUNTY COMMISSIONERS**

Pursuant to Ohio Revised Code Section 4906.08 and Ohio Administrative Code (“OAC”) Rule 4906-2-12, the Preble County Commissioners submit its notice of intervention in the above referenced proceeding. On February 19, 2019, the Preble County Commissioners were served a copy of the Angelina Solar I, LLC (“Angelina”) accepted, complete application to develop, build, and operate the Angelina Solar Farm, an 80 MW solar-powered electric generation facility to be located in Preble County, Ohio.

In accordance with OAC Rule 4906-2-12(A)(1) the Preble County Commissioners state as follows:

- The Preble County Commissioners is the duly elected body authorized to act for Preble County and has taken the required action to intervene, as certified by the attached resolution (Attachment A).
- The proposed facility is to be located entirely in Preble County Ohio within the area under the jurisdiction of the Preble County Commissioners.
- The Preble County Commissioners intend to intervene because it has extensive interest in the proposed project and proceedings as the elected representatives of the citizens of Preble County, Ohio.
- The interests of the Preble County Commissioners are not and cannot be represented by another party; the Preble County Commissioners will contribute to a just and expeditious resolution; and the Preble County Commissioners will not unduly delay the proceedings or unjustly prejudice any party.
