Pursuant to Ohio Revised Code Section 4906.08 and Ohio Administrative Code (“OAC”) Rule 4906-2-12, Preble County Planning Commission, Preble County, Ohio, submits its notice of intervention in the above referenced proceeding. On February 11, 2019, the Preble County Planning Commission was served a copy of the Angelina Solar I, LLC (“Angelina”) application to develop, build, and operate the Angelina Solar Farm, an 80 MW solar-powered electric generation facility to be located in Preble County, Ohio.


In accordance with OAC Rule 4906-2-12(A)(1) the Preble County Planning Commission states as follows:


