**MEMORANDUM IN SUPPORT**

The Commission established the following procedural schedule by Entry on February 8, 2019:

Deadline for Motions to Strike Objections: March 25, 2019

Prehearing Conference: March 25, 2019

Hearing Start Date: April 25, 2019<sup>4</sup>

The parties have now filed their objections to the Staff Report and testimony and are prepared to commence settlement negotiations. However, per the approved waiver, actual valuation data and operating income statements are not due until April 29, 2019.<sup>5</sup> In order to allow sufficient time for negotiations to occur and for the actual data to be provided, Suburban requests that the Commission modify the procedural schedule as follows:

Prehearing Conference: April 8, 2019 at 10:00 a.m.

Hearing Start Date: May 22, 2019 at 10:00 a.m.

This procedural schedule is necessary to allow the parties sufficient time to review actual valuation data and operating income statements and to explore settlement options in advance of the hearing. Suburban has contacted Staff and all intervening parties and neither Staff nor the other parties object to the continuance of the prehearing conference or the hearing start date as set forth herein.

As the date for the prehearing conference in this matter is approaching quickly, Suburban requests that the Commission issue an expedited ruling on this motion pursuant to Ohio Adm. Code 4901-1-12(C). Suburban is able to certify that no party objects to the issuance of such an expedited ruling.

For the reasons stated herein, Suburban requests that the Commission grant this motion on an expedited basis pursuant to Ohio Adm. Code 4901-1-12 and modify the procedural schedule as requested herein.
