Delaware Township Electric Government Aggregation Program

March 29, 2019

Dear Delaware Township Resident,

Delaware Township has selected ______ as the next supplier of electricity to participants in its Electric Aggregation Program for its next term. You will continue to participate in the Township's Electric Aggregation Program with ______ as your supplier, unless you notify ______ that you no longer wish to participate.

Under governmental aggregation, the Delaware Township acts on behalf of electric consumers in the Township to negotiate an electric supply contract with an eligible provider. Both the Township and eligible retail electric suppliers have to be certified by the Public Utilities Commission of Ohio. The Township passed an ordinance to adopt the Electric Aggregation Program after the Township's voters approved its implementation in November of 2013.

Under this aggregation program, beginning with May 2019, eligible residents and businesses in the Township will pay a fixed rate of \$0.0490 cents per kWh for 36 months. The price applies to the generation and transmission portion of your bill. If you are ever unhappy with your service or rate from ______, you may cancel free of charge at any time and return to AEP Ohio at a rate and terms that may or may not be the same as what other Township customers pay.

After you become a participant in the Delaware Township Electric Aggregation Program, _____ will send a letter confirming your selection of ______ as your retail electric service provider. As required by law, this letter will inform you of your option to cancel your enrollment with ______ within seven business days of the postmark date of the letter. To remain in the Delaware Township Electric Aggregation Program, you don't need to take any action when this letter arrives. You will be automatically enrolled.

Under this aggregation, AEP Ohio will continue to maintain the wires system that delivers power to your home or business. You will still contact AEP Ohio regarding loss of power service or for any other concerns or issues having to do with your electric service. You will continue to receive a single bill from AEP Ohio for your electric service with your aggregation rate included.
