Pursuant to Rule 4901:1-24-09(B) of the Ohio Administrative Code, Optimum Power Investments, LLC (“Optimum Power”) seeks an extension of Certificate No. 17-1207E(1), which was issued in Case No. 17-614-EL-CRS. The expiration date of Certificate No. 17-1207E(1) is March 31, 2019. Due to the press of other business including a business reorganization, Optimum Power was not able to file its renewal application on time. It has now filed its renewal application on March 27, 2019 which is four calendar days prior to the March 31, 2019 expiration date. Optimum Power respectfully requests that Certificate No. 17-1207E(1) be automatically extended from March 31, 2019 until April 27, 2019 or until the date that the renewal certificate is issued.

WHEREFORE, Optimum Power Investments, LLC respectfully requests that Certificate No. 17-1207E(1) be automatically extended to April 27, 2019 or until a renewal certificate is issued and authorize it to continue to operate during the pendency of the renewal application certification review.
