Dear Ms. McNeal:

The October 5, 2017, Opinion, Order, and Certificate (“Certificate”) approving Guernsey Power Station, LLC (“GPS”) Certificate of Environmental Compatibility and Public Need to Construct the Guernsey Power Station approved the Stipulation which set forth a set of conditions as part of the Certificate.

Within this set of conditions, **Condition No. 2** requires that:

GPS shall conduct a preconstruction conference prior to the start of any construction activities. Staff, GPS, and representatives of the prime contractor and all subcontractors for the project shall attend the preconstruction conference. The conference shall include a presentation of the measures to be taken by GPS and contractors to ensure compliance with all conditions of the certificate, and discussion of the procedure of on-site investigations by Staff during construction. Prior to the conference, the Applicant shall provide a proposed conference agenda for Staff review. The Applicant may conduct separate preconstruction meetings for each stage of construction.

In compliance with **Condition No. 2**, GPS notifies the Staff of the Ohio Power Siting Board (“Board” or “OPSB”) that GPS held a preconstruction conference with the OPSB Staff on March 18, 2019 for a stage of construction to grout open mine voids at the project site. A conference agenda was provided in advance, on March 12, 2019. The conference was held with representatives from the Ohio Department of Transportation and was attended by the relevant consultants and contractors, including Gemma, Tetra Tech, and Howard Concrete, for this stage of construction.

At the conference, GPS provided the OPSB Staff documentation demonstrating compliance with the other Certificate conditions applicable to this stage of construction. These conditions include **Condition No. 6**, pertaining to mine grouting construction activities, and **Condition No. 24**, requiring the submission of an emergency response plan.

As a result, this notice indicates that GPS is in compliance with the applicable Certificate condition for the limited stage of construction to group open mine voids.
