Second Supplement to Application – Summary of Second Public Information Meeting

Dear Ms. Troupe:

On January 31, 2019, as supplemented on March 18, 2019, Firelands Wind, LLC ("Applicant") filed an application with the Ohio Power Siting Board ("Board") for a Certificate of Environmental Compatibility and Public Need to Construct a Wind-Powered Electric Generation Facility in Huron and Erie Counties, Ohio ("Application").

The Applicant held a public information meeting on November 15, 2018, to discuss the proposed project with interested persons. On March 7, 2019, the Administrative Law Judge ("ALJ") directed the Applicant to hold a second public information meeting. The second public information meeting was held from 5:00 p.m. to 7:00 p.m. on Wednesday, April 3, 2019, at the Bellevue VFW, 6104 Highway 20, Bellevue, Ohio 44811.

On March 29, 2019, the ALJ granted the request from the Executive Director of the Board for an extension of the completeness deadline until April 17, 2019, in order to permit the Applicant time to conduct the public informational meeting on April 3, 2019, and file a summary of how many and what types of comments were received from the public during the meeting.

At this time, the Applicant files the following in accordance with the ALJ's March 29, 2018 entry and as a second supplement to the Applicant's response to Ohio Administrative Code Rule 4906-4-04(B)(3). Over 200 people attended the second public information meeting, which was held on Wednesday, April 3, 2019, at the Bellevue VFW in Bellevue, Ohio. In addition to the verbal comments that were shared at the meeting, 111 individuals provided written comments at the public information meeting. The Applicant provided all of the written comments from both the first and second public information meetings to the Board's staff for filing as comments in the docket. The verbal and written comments focused on: economic development and jobs brought to the community and state; environmental benefits; tax revenues to schools and others that receive

tax revenues; air quality benefits; landowner and neighbor benefits; setbacks; sound; shadow flicker; the project's lighting; cultural impacts; ecological impacts on wildlife; benefits of clean renewable energy; roads and transportation; process for decommissioning; risks to health and safety; the need for and reliability of wind power; the location of Karst in the area and impacts of the project on the area's water system and wells; air travel and Federal Aviation Administration requirements; impacts on tourism, property values, television and communications systems; and tax subsidies.
