**AMENDED NOTICE TO TAKE DEPOSITION AND REQUESTS FOR
PRODUCTION OF DOCUMENTS BY

Pursuant to Ohio Adm. Code 4901-1-21(B), please take notice that Suburban Natural Gas Company (Suburban) will take the deposition of Wm. Ross Willis on April 25, 2019 at 1:00 p.m. Although Suburban previously noticed its intent to depose Mr. Willis on April 24, 2019 at 10:00 a.m., the date and time of the deposition has changed as agreed to by the Parties. As such, Suburban will now take the deposition of Mr. Willis upon oral examination at the offices of the Office of the Ohio Consumers' Counsel, 65 East State Street, 7th Floor, Columbus, Ohio 43215, or at a location that is mutually agreeable to the parties, on April 25, 2019 at 1:00 p.m. The deposition will continue, from day to day, except for holidays and weekends, until it is completed. Mr. Willis will appear at the agreed-upon location at the designated time and date with all documents requested below and remain present until the deposition is complete.

The deposition of Mr. Willis will be taken on relevant topics within the scope of these proceedings, including, but not limited to, the subject matter of Mr. Willis's testimony that was filed on March 8, 2019 and Mr. Willis's general knowledge, experience, and expertise concerning the matters at issue in this proceeding. The deposition will be taken upon oral examination (as upon cross-examination) before an officer authorized by law to take depositions.

Pursuant to Ohio Adm. Code 4901-1-21(E), Mr. Willis is requested to produce, at least 48 hours prior to the commencement of his deposition, the following:

1. Any and all workpapers, documents, spreadsheets, contracts, or other materials relied upon by Mr. Willis in preparing his testimony in this proceeding.
2. Any and all workpapers, documents, contracts, spreadsheets, contracts, or other materials referenced in the testimony of Mr. Willis.
3. Any and all reports, studies, analyses, assessments, or other documents prepared by Mr. Willis as part of his work regarding the above-captioned proceedings that were not included in Mr. Willis's testimony that was filed on March 8, 2019.
