In an Entry issued on April 11, 2018, in Case No. 18-264-EL-UNC, the Commission selected Oxford Advisors, LLC (Oxford) as the third-party monitors to assist Staff in performing the compliance review of DP&L's Rider DMR. The timeline in the O&O requires Oxford to file an interim report sixty days after a request is received by DP&L to extend the Rider DMR. DP&L filed its Rider DMR extension request on January 23, 2019, in Case No. 19-162-EL-RDR, making the interim report due by March 22, 2019. The Staff hereby requests that the due date for the interim report be extended to April 29, 2019. The reasons for this motion are set forth in the accompanying Memorandum in Support.
