**ISSUES LIST OF ANGELINA SOLAR I, LLC**

Pursuant to the Administrative Law Judge’s February 14, 2019 entry, Angelina Solar I, LLC (“Angelina”) submits this issues list citing specific concerns about which it may be interested in pursuing cross-examination of Staff witnesses relating to certain conditions contained in the April 15, 2019 Staff Report of Investigation. In addition to the specific concerns identified below in the Staff Report of Investigation, Angelina may also pursue cross-examination of any witnesses appearing on behalf of any intervenor in support of or regarding any issue identified in their petitions or notices to intervene, or with respect to any testimony or evidence presented by any witnesses. The specific issues concerning the Staff Report of Investigation designated by the applicable condition are as follows:

1. Condition 8, regarding the timing of the submission of permits and authorizations to Staff.
2. Condition 22, regarding the filing of the pre-construction access plan.
3. Condition 23, regarding the filing of the frac-out contingency plan.
4. Condition 24, regarding the limitations on the clearing of wooded areas.
5. Any recommendations or statements in the Staff Report of Investigation regarding visual screening, fencing, or landscaping, including any recommendations or statements at page 12.

6. Any recommendations or statements in the Staff Report of Investigation related to plantings or vegetation in areas between solar panels, including any recommendations or statements at page 19.
7. Any recommendations or statements in the Staff Report of Investigation related to compliance with safety standards, including any recommendations or statements at page 28.
