Dear Ms. Troupe:

Columbia Gas of Ohio, Inc. ("Columbia") filed an Application for Authority to Implement a Capital Expenditure Program and for Approval to Change Accounting Methods ("CEP Deferral") in Case Nos. 11-5351-GA-UNC and 11-5352-GA-AAM. The Commission issued a Finding and Order ("Original Order") on August 29, 2012 approving the Application with modifications.

On December 24, 2012, Columbia filed an Application to continue its CEP Deferral and the previously approved accounting treatment. Consistent with the Original Order, the Commission, in its October 9, 2013 Finding and Order ("Extension Order"), authorized Columbia to continue the CEP Deferral.

In paragraph 32(f) of the Original Order and adopted in paragraph 14 of the Extension Order, the Commission directed Columbia to docket an annual informational filing of the CEP Deferral by April 30 of each year.

Pursuant to both Orders, Columbia filed the applicable information on February 28, 2019, with its application to adjust the CEP Rider in Case No. 19-438-GA-RDR. Therefore, no additional information is necessary to be filed in this docket.
