**DUKE ENERGY OHIO, INC.'S MOTION FOR LEAVE TO FILE  
2018 INFORMATIONAL REPORT, INSTANTER**

Now comes Duke Energy Ohio, Inc., (Duke Energy Ohio), and hereby respectfully moves the Public Utilities Commission of Ohio (Commission) for leave to file its 2018 Informational Report concurrently with this Motion, Instanter.

On May 3, 2019, Duke Energy Ohio filed an application (Application) for a new alternative rate plan to establish a capital expenditure program rider (Rider CEP). The Application included information relating to 2018 expenditures, as had historically included in the annual informational reports filed by April 30 of each year, beginning in 2015, in the above-captioned dockets. Duke Energy Ohio assumed, due to that inclusion in the Application, that the 2018 separate filing would not be necessary. Duke Energy Ohio was notified by Staff on May10, 2019, that a regular 2018 annual informational report would still be necessary. Therefore, Duke Energy Ohio is filing its 2018 informational report, concurrently with this motion.

## **MEMORANDUM IN SUPPORT**

### **I. INTRODUCTION**

On December 20, 2013, Duke Energy Ohio, Inc., (Duke Energy Ohio or Company) filed an application in the above-captioned cases, seeking approval of a Capital Expenditure Program (CEP). On October 1, 2014, the Public Utilities Commission of Ohio (Commission) issued a Finding and Order (Order), modifying and approving the Application.

In the Order, the Commission required the Company to make annual informational filings regarding its CEP on April 30 of each year, beginning in 2015. On May 3, 2019, Duke Energy Ohio filed an Application for a new alternative rate plan to establish a capital expenditure program rider (Rider CEP). Within that application, as an exhibit, Duke Energy Ohio included the 2018 annual informational filing calculations, assuming a separate filing would not be necessary.

### **II. DISCUSSION**

Duke Energy Ohio respectfully submits that good cause exists for this Commission to consider its 2018 information report, filed concurrently herewith, as filed timely and allow the 2018 informational report to be considered in the disposition of this case.

Permitting the late filing of the 2018 informational report will not prejudice parties or cause any delay.

### **III. CONCLUSION**

Due to the Company's incorrect assumption that a separate filing would not be required, Duke Energy Ohio did not file its 2018 informational report in these dockets by April 30. Accordingly, the Duke Energy Ohio requests that the Commission grant its Motion for Leave to File 2018 Informational Report, Instantly.
