## JOINT MOTION FOR AN EXTENSION AND CONTINUANCE SUBMITTED ON BEHALF OF THE STAFF OF THE PUBLIC UTLITIES COMMISSION OF OHIO

The Staff of the Public Utilities Commission of Ohio ("Staff") and Suburban Natural Gas Company ("Suburban"), pursuant to Rules 4901-1-12 and 4901-1-13 of the Ohio Administrative Code (O.A.C.), respectfully requests an extension of the filing deadline for Staff's testimony and a continuance of the May 20, 2019 hearing date. The March 25, 2019 Entry rescheduled the hearing in this case to begin on May 9, 2019 and to recommence on May 20, 2019. At the prehearing on April 25, 2019, the parties agreed that Staff's testimony would be filed on May 16, 2019. On May 9, 2019, the hearing began as scheduled. Subsequent to May 9, 2019, Staff and Suburban have reached a stipulation in principle. In order to allow Staff and Suburban additional time to formalize and file a stipulation, Staff and Suburban are requesting the following: 1) a continuance of the May 20, 2019 hearing date; 2) the extension of the deadline for filing Staff's testimony, to avoid the filing of Staff testimony prior to finalizing a stipulation; 3) using the May 20, 2019 hearing date as a hearing on procedural matters to discuss the deadlines and hearing dates moving forward; and 4) that the Commission grant this motion on an expedited basis pursuant to O.A.C. 4901-1-12(C)
