#### MEMORANDUM IN SUPPORT

Pursuant to Ohio Adm.Code 4906-3-01(B) and Ohio Adm.Code 4906-2-27, the Staff of the Ohio Power Siting Board (Staff) respectfully moves the Ohio Power Siting Board (Board) to grant a waiver of certain timing requirements of Ohio Adm.Code 4906-6-06(B) and Ohio Adm. Code 4906-6-10(A). Staff also requests an expedited ruling in this matter pursuant to Ohio Adm. Code 4906-2-27(C).

Ohio Adm.Code 4906-5-05 allows for an accelerated certificate application process for eligible construction projects. In that accelerated process, Ohio Adm.Code 4906-6-06(B) states that:

- (B) Staff shall conduct an investigation of each accelerated certificate application and submit a written report no less than seven calendar days prior to the automatic approval date.
- (1) The report shall set forth the nature of the investigation and shall contain recommended findings with regard to section 4906.10 of the Revised Code.
- (2) The report shall become part of the record and shall be provided to board members, the administrative law judge assigned to the case, the applicant, and all persons who have become parties to the proceedings. Copies shall be made available to any person upon request.

Ohio Adm.Code 4906-6-10(A) states that:

(A) Staff shall recommend an automatic approval date for an accelerated application in its written report of investigation to the board, unless staff is recommending suspension of the automatic approval date. The recommended automatic approval date shall be no sooner than seven calendar days after the filing of the written report of investigation and no later than ninety days after the filing date of the application.

Staff inadvertently has not filed a Staff Report in this case. Staff is required to conduct an investigation and submit a Staff Report for this accelerated certificate application. A Staff Report will allow for a thorough review of the project as it relates to R.C. 4906.10 and allow for a full development of the record in the case. As a result, good cause exists to grant the requested waiver of the timing requirements of Ohio Adm.Code 4906-6-06(B) and Ohio Adm.Code 4906-6-10(A).

Ohio Adm.Code 4901-2-27(C) allows a party to request that the Board consider a motion on an expedited basis. No party opposes this motion for waivers. Accordingly, Staff respectfully requests an expedited ruling granting the waiver of the timing requirements of Ohio Adm.Code 4906-6-06(B) and Ohio Adm.Code 4906-6-10(A). If the Board grants this motion, the Staff will file its written report of investigation immediately following the entry granting this motion.
