- {¶ 1} In this Entry, the attorney examiner grants Staff's request for an extension of the filing date for the mid-term report of the third-party monitor.
- {¶ 2} The Dayton Power and Light Company (DP&L or the Company) is a public utility and an electric distribution utility as defined under R.C. 4905.02 and R.C. 4928.01, respectively. Therefore, DP&L is subject to this Commission's jurisdiction.
- {¶ 3} R.C. 4928.141 mandates that an electric distribution utility shall provide a standard service offer (SSO) of all competitive retail electric services necessary to maintain essential electric service, including a firm supply of electric generation service, to all consumers within its certified territory. The SSO may be established as a market rate offer under R.C. 4928.142 or an electric security plan (ESP) under R.C. 4928.143.
- {¶ 4} On October 20, 2017, the Commission approved, with modifications, DP&L's application for an ESP. *In re the Application of Dayton Power and Light Co. to Establish a Std. Serv. Offer in the Form of an Electric Security Plan*, Case No. 16-395-EL-SSO (ESP Order), Opinion and Order (Oct. 20, 2017). As part of the approved ESP, the Commission authorized DP&L to implement a distribution modernization rider (Rider DMR). The Commission further directed Staff to conduct an ongoing review of the use of Rider DMR cash flow during the term of the ESP. ESP Order at ¶43. Additionally, to provide assistance for the anticipated review, we instructed Staff to prepare a request for proposal (RFP) for a third-party monitor to assist Staff and work with DP&L and its parent company, DPL Inc. (collectively, the Companies). *Id*.

{¶ 5} On February 28, 2018, the Commission issued an Entry in the above-captioned proceeding directing Staff to issue an RFP for the necessary third-party monitor services. On April 11, 2018, the Commission selected Oxford Advisors, LLC, (Oxford) to serve as the third-party monitor.

- {¶ 6} In the ESP Order, the Commission directed the monitor to file a mid-term report of its review of Rider DMR in any proceeding in which DP&L seeks an extension of Rider DMR, within 60 days after the filing of the application seeking such extension. ESP Order at ¶43.
- {¶ 7} On January 23, 2019, DP&L filed an application in Case No. 19-162-EL-RDR seeking an extension of Rider DMR. Accordingly, the mid-term report was scheduled to be filed by Oxford in that docket by March 22, 2019.
- {¶ 8} By Entry dated March 21, 2019, and again on April 26, 2019, the attorney examiner granted motions to extend the scheduling deadline. The latter Entry indicated that the mid-term report should be filed by May 31, 2019, unless otherwise ordered by the Commission.
- {¶ 9} On May 29, 2019, Staff filed a motion for an extension of time to file the midterm report. Staff represents that Oxford has requested additional time to complete the midterm report; thus, Staff asks that the date for filing the report be extended to June 14, 2019.
- {¶ 10} The attorney examiner finds that the motion for an extension of time is reasonable and should be granted. Accordingly, Oxford shall file the mid-term report in the docket for Case No. 19-162-EL-RDR by June 14, 2019, unless otherwise ordered by the Commission.
