Hello,

Below is the letter that I have sent to Mike Dewine as well as our State Representative Shane Wilkin requesting their input on the 3500 Acres Highland County Solar Farm.

I am writing to you to request guidance on how to appeal a decision made by the OPSB for the Highland Solar Farm. It appears they have approved the Highland Solar Farm, I have read through the approval online and am unable to understand how such need has been found in this small community. This is a solar farm that will consume 3500 acres of farm land in Clay Township Ohio. We as residents were invited to attend a public meeting and speak and to send in our comments but have not received any replies or answers to our concerns or questions regarding this project. It is being sold on the fact the county will receive tax money, the jobs promised are nowhere near what Hecate stated in their proposal and our community will suffer. It appears from what I have read that the OPSB is allowing Hecate to come into our lives and destroy the land ALL around us! OPSB, the Highland County Commissioners nor the Clay Township Trustees has reached out to any of the residents that this affects. I have personally sent letters to them and no contact has been made to help our concerns.

Most of the support that was mentioned by the OPSB in their report was solicited by Hecate (form letters) from Ohio residents of which most do not live within Highland County. Most of the meetings held by Hecate and the Highland County Commissioners were in executive session and we the public were informed of very little. As a resident we have had NO support from our county or local government on this issue. When speaking to someone and mentioning this project they seem to be in shock, this has been kept quiet and now we as private citizens seem to have no rights. The size of this farm will greatly alter our quality of life and will forever change this small community, and not for the good.

All rural counties with no zoning requirements are being preyed upon by these large corporations and our wide open land is being destroyed. The locals are the ones paying for it and the power is being sent to other states.
