## MEMORANDUM IN SUPPORT

---

Pursuant to Ohio Adm.Code 4901-1-12 and 4901-1-13, the Staff of the Commission respectfully moves for an extension of the procedural schedule in this proceeding. Because the deadline for direct testimony is June 7, 2019, Staff also requests an expedited ruling in this matter pursuant to Ohio Adm. Code 4901-1-12(C).

By entries dated March 18, 2019 and May 31, 2019, the Attorney Examiners adopted a procedural schedule for this proceeding as follows:

1. Deadline for filing Staff's and OCC's testimony is June 7, 2019; and
2. The hearing is scheduled to begin June 11, 2019.

The parties have engaged in settlement negotiations that may resolve one or all issues between some or all of the parties. In order to facilitate continued settlement discussions and explore whether a partial or complete settlement may be reached, Staff requests an extension of the procedural schedule. Specifically, Staff requests that the Attorney Examiners extend the procedural schedule in this case as follows:

1. Deadline for filing Staff's and OCC's testimony is July 9, 2019; and
2. The hearing is scheduled to begin July 16, 2019.

Ohio Adm.Code 4901-1-12(C) allows a party to request that the Commission consider a motion on an expedited basis. No party opposes the motion for extension and request for immediate ruling. Accordingly, Staff respectfully requests an expedited ruling for the extension of the procedural schedule.
