Phase 3 – Compliance with Conditions Prior to Construction

Dear Ms. Troupe:

Hardin Wind Energy LLC ("Applicant") is certified to construct a wind-powered electric generation facility in Hardin County, Ohio, in accordance with the orders issued by the Ohio Power Siting Board ("OPSB") in the above-referenced cases.

Over the last several years, the Applicant has been engaged in a continuous course of construction of the project via a phased approach. Phase 1 included the excavation and construction of some of the turbine locations, and Phase 2 included the interconnection substation. The Applicant is currently preparing to begin Phase 3 of the project, which will entail construction of the access roads and turbine foundations that were not included in Phase 1. Phase 3 will not include the electrical system installation work or the erection of the turbines, because that construction will occur in a later phase of the project. Compliance with certificate conditions applicable to the electrical system installation work and erection of turbines will be completed prior to that phase of the project.

The Applicant is providing the following information for purposes of explaining the status of compliance with the certificate conditions for Phase 3 of the project. Documentation of compliance regarding any conditions that are not listed below, but are required prior to construction, will be filed in the docket prior to construction.
