Applicable to all customers receiving service under the Company's sales and transportation rate schedules.

The charges for the respective gas service schedules are:

Rate RS and RSLI, Residential Service	\$.60/month
Rate RFT and RFTLI, Residential Firm Transportation Service	\$.60/month
Rate GS-S and GS-L, General Service	\$.60/month
Rate FT-S and FT-L, Firm Transportation Service	\$.60/month
Rate IT, Interruptible Transportation Service	\$.60/month
Rate GGIT, Spark Spread Interruptible Transportation Rate	\$.60/month

The credit to be given to Duke's gas only customers for the respective gas service schedules are:

Rate RS and RSLI, Residential Service	(\$.29/month)
