MOTION TO WITHDRAW AS COUNSEL OF RECORD

Now comes Joshua D. Clark, Assistant Prosecuting Attorney for Seneca County, Ohio, and moves the Ohio Power Siting Board for an order to withdraw as counsel of record for the Board of Seneca County Commissioners, the Seneca County Park District and the Board of Trustees of Scipio Township, Seneca County, Ohio.

For cause, Joshua D. Clark states that there is a conflict of interest in representing the Board of Seneca County Commissioners and other parties currently involved in the case captioned above, specifically the Seneca County Park District and the Board of Trustees of Scipio Township, Seneca County, Ohio. It is the understanding of the undersigned that at least one party will not execute a written waiver of the conflict.

Initially our office agreed to represent the parties involved on a very limited scope pertaining only to filing their intervention petitions with the OPSB, and this was understood by all parties. Since this step of the process has been completed, we are requesting to withdraw on the grounds that any further representation not only puts us in conflict but goes beyond the scope of our stated engagement.

For these reasons, Joshua D. Clark respectfully requests that he be allowed to withdraw as counsel of record for the Board of Seneca County Commissioners, the Seneca County Park District and the Board of Trustees of Scipio Township, Seneca County, Ohio.
