TESTIMONY**

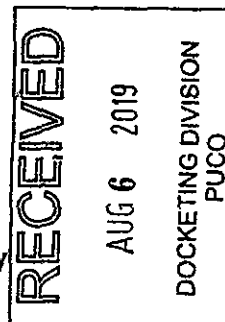
Now comes Respondent, The Village of Perry, by and through Counsel, and respectfully moves for an Order continuing the Hearing in the above-captioned matters currently set for Thursday, August 15, 2019, at 10:00 a.m., and re-setting the Hearing to September 26, 2019, and deadline for identifying testimony from August 8, 2019, to September 19, 2019.

Counsel for Respondent states that the basis for said request is as follows:

1. Defense counsel has a previously scheduled Hearing in Ashtabula County Common Pleas Court (Jefferson, Ohio) Case No. 2018 CV 00771, entitled Patricia J. Schraff, etc. v. Cassandra Webster, et al., in the Court room of the Honorable Judge Thomas E. Harris on August 15, 2019, at 9:30 a.m., that will prohibit him from attending the August 15th Hearing before the Public Utilities Commission at its presently scheduled time.


2. Prior to filing this Motion, I consulted with the attorney for Complainant, Stephen W. Counsel then discussed their respective schedules and agreed upon a new hearing date of September 26, 2019.
