## **MEMORANDUM IN SUPPORT**

This motion seeks to reopen the record in this proceeding to allow for additional information to be presented to the Board on the modification related to an underground collection line for the Nestlewood Solar Project. The modification was submitted to the Board, first, on May 24, 2019, when Nestelwood filed its Notice Regarding Modification of Project Footprint ("Modification"). The Modification was included as part of the record at the evidentiary hearing, and Ms. Gresock, a witness for Nestlewood, testified on the Modification at the June 3, 2019 hearing.<sup>1</sup>
