Pursuant to Ohio Admin. Code 4906-6-03(A), Columbia Gas of Ohio, Inc. ("Columbia") submits this pre-application notification letter to the Ohio Power Siting Board ("OPSB"). On or about September 4, 2019, Columbia intends to file a Construction Notice in this docket concerning a proposed pipeline replacement referred to as the Huntley/Wilson Bridge Roads Mandatory Relocation Project (the "Project") within the City of Worthington, in Franklin County, Ohio.

Columbia requests the 90-day accelerated review under Ohio Admin. Code Chapter 4906-6. The Project meets the requirements for accelerated review as a Construction Notice under Ohio Admin. Code 4906-6-01, Appendix B because it is a replacement of gas pipeline facilities less than one mile in length as well as a replacement or relocation of gas pipeline facilities where the project is required by publicly funded entities and is located on or adjacent to new right-of-way owned by the public entity requiring the project.

Columbia will begin construction on February 3, 2020, and Columbia expects an in-service date on or about May 4, 2020. Pursuant to Ohio Admin. Code 4906-06-11, Columbia will file a timely notice of construction ending with the OPSB.
