## THE EAST OHIO GAS COMPANY D/B/A DOMINION ENERGY OHIO'S SUPPLEMENT TO CONSTRUCTION NOTICE

On August 27, 2019, the Ohio Power Siting Board Staff issued its Staff Report, which contains the 4 conditions listed below:

- Prior to the commencement of construction activities in areas that require permits or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant.
- 2) The Applicant shall adhere to seasonal cutting dates of October 1 through March 31 for removal of any trees greater than or equal to three inches in diameter, unless coordination efforts with the Ohio Department of Natural Resources (ODNR) and the U.S. Fish and Wildlife Service (USFWS) allow a different course of action.
- 3) The Applicant shall segregate soils during construction activities that involve the disturbance of top soil and restore any disturbed area to original or better conditions. This condition may be waived with the consent of the property owner.
- 4) Where the installation of the pipeline results in damage to driveways, parking areas, or roads, the impacted areas shall be repaired promptly to their preconstruction state.

By this submission, The East Ohio Gas Company d/b/a Dominion Energy Ohio ("DEO") incorporates the above conditions as a supplement to its Construction Notice filed August 27, 2019, and requests that this supplement be considered part of DEO's application.
