**MOTION FOR PERMISSION FOR CHRISTOPHER W. FLYNN TO APPEAR
PRO HAC VICE BEFORE THE COMMISSION**

Pursuant to Rule XII of the Supreme Court Rules for the Government of the Bar of Ohio, the Public Utilities Commission of Ohio (Commission) is respectfully requested to grant Christopher W. Flynn (PHV-21537-2019) permission to appear pro hac vice and participate as co-counsel on behalf of The East Ohio Gas Company d/b/a Dominion Energy Ohio in the above-captioned proceedings.

Mr. Flynn has been licensed to practice law in Illinois. His Bar No. is 6187549 and he was admitted on November 16, 1984. He is not, and has never been, licensed in any other state. No disciplinary action has been taken against Mr. Flynn's since he was granted permission to appear. Mr. Flynn's residential address, office address and name and address of employer are as follows:

Mr. Flynn has not been granted permission to appear *pro hac vice* in more than three proceedings before Ohio tribunals in the current calendar year in accordance with Gov. Bar Rule XII(2)(A)(6). Under that Rule, participation in a Commission proceeding – including a proceeding involving “the consolidation of two or more” Commission case numbers – counts as a single proceeding in the year the *pro hac vice* motion is granted. Gov. Bar Rule XII(2)(A)(6). In addition, any “appeal of [a Commission] order or ruling . . . shall not be counted toward the annual limitation,” and if “a proceeding continues to the next or subsequent calendar years, the proceeding will not count toward the annual limitation.” *Id.*

Christopher T. Kennedy (#0075228), an attorney licensed to practice in the State of Ohio in good standing, has agreed to associate with Mr. Flynn in this proceeding.

Attached are a copy of the certificate of *pro hac vice* registration for Mr. Flynn furnished by the Supreme Court of Ohio Office of Attorney Services, a copy of the affidavit required by Gov. Bar R. XII(2)(A)(6), and a certificate indicating service of this Motion on all known parties and attorneys of record.

Mr. Flynn understands that, if this Motion is granted, he must file a Notice of Permission to Appear *Pro Hac Vice* and a copy of the Order granting permission with the Office of Attorney Services within thirty days of the Order.

WHEREFORE, the Commission is respectfully requested to grant permission for Christopher W. Flynn to appear *pro hac vice* before the Commission in this proceeding.



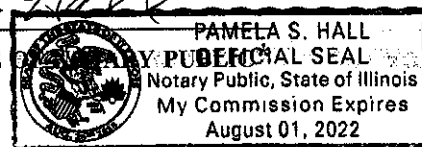
