5 The Public Utilities Commission of Ohio has
6 assigned for public hearing at this time and
7 place Case Nos. 18-1720-GA-AIR, 18-1721-GA-ATA,
8 and 18-1722-GA-ALT being in the matter of the
9 application of Northeast Ohio Natural Gas Corp.
10 for approval of an increase in gas distribution
11 rates, combined with an application for tariff
12 approval and approval for an alternative rate

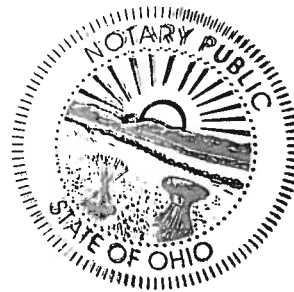
