MOTION FOR EXTENSION

Pursuant to Ohio Administrative Code Rule 4901:1-24-09(B), Empower Gas & Electric, LLC (“Empower Gas & Electric”) seeks an extension of Certificate No. 15-460G(2), which was issued in Case No. 15-1329-GA-CRS. The expiration date of Certificate No. 15-460G(2) is September 15, 2019. Due to pressing business issues and recent changes in personnel at Empower Gas & Electric, it was not able to file its renewal application on time. It filed its renewal application on September 13, 2019, which was 28 business days after the deadline and is prior to the September 15, 2019 certificate expiration date. Empower Gas & Electric respectfully requests that Certificate No. 15-460G(2) be automatically extended from September 15, 2019, until October 15, 2019, or until the date that the renewal certificate is issued.

WHEREFORE, Empower Gas & Electric respectfully requests that Certificate No. 15-460G(2) be automatically extended to October 15, 2019, or until a renewal certificate is issued, and authorize it to continue to operate during the pendency of the renewal application certification review.

**MEMORANDUM IN SUPPORT OF
MOTION FOR EXTENSION**

Due to pressing business issues and recent changes in personnel at Empower Gas & Electric, LLC, it did not meet the August 15, 2019 filing date for its renewal application in Case No. 15-1329-GA-CRS. It filed the renewal application 28 business days later, on September 13, 2019. Empower Gas & Electric apologizes for this delay.

Ohio Administrative Code Rule 4901:1-24-09(B) provides that a motion requesting an extension of a certificate will be deemed automatically approved (unless ruled otherwise by the Commission or an Attorney Examiner within three business days), if a renewal application is filed fewer than 30 calendar days prior to the expiration date of the certificate but no later than the expiration date. Empower Gas & Electric submits that it has met this criteria and respectfully requests an automatic extension of the expiration date of Certificate No. 15-460G(2) issued in Case No. 15-1329-GA-CRS to October 15, 2019, or until such time as a renewal certificate is issued.
