"Upon arriving at church, the lay reader was in tears. Her granddaughter had just called her moments earlier to say that two of her closest friends were killed in Dayton. These two friends were to be bridesmaids in her wedding scheduled for 2020."

Bartel began his one-page message with the two words that have become the rallying cry since the Aug. 4 mass shooting: "Do something."

In the month after 10 people died, including the shooter, and 27 were wounded in downtown Dayton's Oregon District, more than 3,600 people poured out their hearts to the leader of their state through calls, letters and emails. Many of those contacts came from people with personal connections to the shooting, ranging from a teacher who taught students in the area to a priest from Dayton to a doctor at the hospital where victims were treated. One envelope arrived covered with splatters and the message "Their Blood is On Your Hands."

Angela Ruffalo of Dayton summed up the

sentiment of many about the tragedy in her hometown: "A young man killed 9 people & injured over 20 people in LESS THAN 30 SECONDS!! 30 Seconds!!! If that does not shock & scare you, I don't know what will. How many more innocent people need to die before you take any kind of action to protect us?"

Of the 3,098 emails received, 2,595 encouraged new gun restrictions, while 503 were what the governor's office categorized as "pro-Second Amendment."

"Do not dare infringe on our constitution," warned one writer in the latter category. "President Trump and you will lose election if anything is passed."

Another said, "When will all of you get it? It's not about the guns. The guns don't go out and kill people. People kill people."

The governor doesn't read these notes, but top policy and constituent affairs staff members do, said DeWine spokesman Dan Tierney. The notes were obtained by

The Dispatch after a public-records request.

Two days after the Dayton killings, DeWine outlined a 17-point plan he already had been developing; its proposals include an increase in mental health aid, background checks and a "red flag" law that would allow authorities to confiscate guns from people if a hearing determines they are a danger to themselves or others.

## Notice of Public Information Meeting for Proposed Major Utility Facility

The Ohio State University ("Ohio State") has scheduled a public informational meeting on Thursday, September 26, 2019 to outline plans to install a Combined Heat and Power ("CHP") major unit facility on the Ohio State campus in Clinton Township, Franklin County, Ohio (Ohio Power Siting Board Case No. 19-1641-EL-BGN).

The CHP facility will produce thermal energy powered by natural gas while introducing electricity generation on campus and will serve as a primary source of heating and electricity to the Columbus campus. The CHP facility, with a nameplate maximum output capacity of 105.5 MW, will include the installation of two natural gas combustion turbine generators and one steam turbine generator. The proposed CHP facility site is located on 1.35 acres on the corner of John H. Herrick Drive and Vernon L. Tharp Street. Construction of the CHP facility is estimated to begin in the spring of 2020 and be completed in the autumn of 2021, pending approval from the Ohio Power Siting Board.

The public is invited to learn about the need, project schedule, design, construction, and environmental information for the proposed CHP facility at the public information meeting on campus from 5:30 p.m. to 7:30 p.m., Thursday, September 26, 2019, at the Fawcett Center, 2400 Olentangy River Rd., Columbus, Ohio 43210. Information addressing the CHP facility will be available and representatives from Ohio State and the university's utility system operator will be available to respond to inquiries.
