You are receiving this letter because you own property or live in the area that's part of AEP Ohio's Fostoria-Fremont Transmission Line Rebuild Project, which was filed with the Ohio Power Siting Board (OPSB) as the Buckley Road-Fremont Center 138kV Transmission Line. I'm writing to provide an update about the project.

AEP Ohio filed the enclosed amendment with the OPSB on September 26, 2019 that includes minor changes to the application we previously submitted for the project on January 30, 2018. Since we submitted that application, the following events took place leading up to the recently-filed amendment:

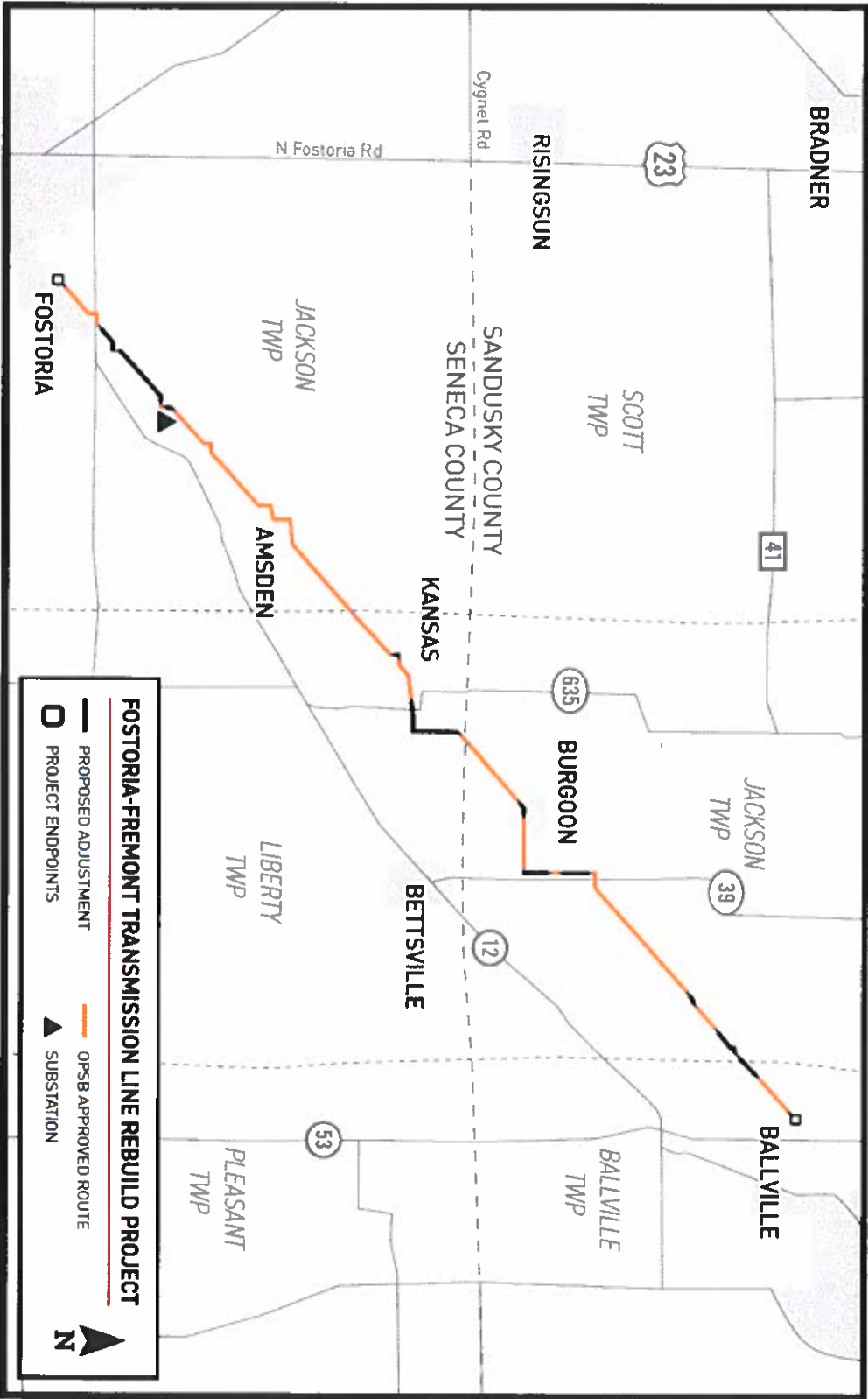
- The OPSB certified the application as complete on April 2, 2018 based on the requirements outlined in the Ohio Administrative Code (OAC) 4906-3-06 (A)(1)
- The OPSB approved the application on September 20, 2018 under Case No. 17-2085-EL-BTX
- The OPSB issued the certificate for the construction, operation and maintenance of the transmission facilities along the alternate power line route.

Plans involve upgrading approximately 15 miles of power line between the Fostoria and Fremont in Seneca and Sandusky counties. The project helps ensure electric service reliability in the area.
