



Single Primary Access Line Bus:	\$13.80	\$15.80
Single Primary Access Line Res:	\$12.55	\$14.55

The new rates, which will become effective on October 1, 2019, represent an increase of \$2.00 above the current rates for those services. This increase will not affect business customers under contracts.
