Application for Rehearing

In response to the Entry on Rehearing entered in the Journal on October 9th, 2019, Solarstone Limited, an Ohio LLC and CRES provider (certificate 18-1345E), is applying for rehearing in regards to the assessment of "a \$1,000 forfeiture on the entities listed on the attachment", among which Solarstone Limited is listed.

Regarding the 2018 Annual Report to be submitted by September 30th, 2019, it is to be noted that Solarstone filed the 2018 annual report by the September 30th deadline (Exhibit A). Furthermore, it is to be noted that Solarstone was granted certification as a CRES provider on November 26th, 2018 (Exhibit B), allowing the company to provider brokerage and aggregation services effective November 26th, 2018. The company did not transact any of the said services in 2018 and management was not aware that an annual report was required for Solarstone's one month of active certification as a CRES provider in 2018. In fact, management was not even in the United States for the remainder of the 2018 calendar year upon being certified and the company was unaware of the Commission's approval for CRES certification until January 2019.

Furthermore, Solarstone has paid invoice "19-00021546 Annual Assessment – Fall" (Exhibit C) for \$100 as of November 1st, 2019. Although Solarstone was unaware of the need for filing in 2018 given the abbreviated nature of 2018's CRES certification and Solarstone's operations, Solarstone is fully aware that it must file an annual report each year. Solarstone is humbly asking the commission to reconsider and waive the assessment of a \$1,000 forfeiture.




